

RELEASE FORM

I know that I (or my child) am participating in a road ride that is a potentially hazardous activity. I (he/she) should not enter and participate unless I (he/she) am medically able and know and follow all road and biking laws and signals, including but not limited to wearing of a bike helmet that satisfies the Consumer Protection Safety Commission standards throughout the event. I (he/she) agree to abide by any decision relative to my (his/her) ability to safely participate in the 2019 Legacy Ride and assume all risks, including but not limited to falls, contact with other participants, the effects of weather, including heat, wind, cold, humidity, precipitations, traffic, failure of the observance of traffic signals or laws by me or others, road conditions, all such risks being known and appreciated by me.

I consent to emergency medical care and transportation in the event of injury to me (or my child) as medical professionals may deem appropriate. This Release extends to any liability arising out of or in any way connected with the medical treatment and transportation provided in the event of an emergency, including, but not limited to, negligent emergency rescue operations.

I acknowledge, agree, and represent that I understand the nature of bicycling activities and that I am qualified, in good health, and in proper physical condition to participate in such activity. I further acknowledge that this activity will be conducted over public roads and facilities open to the public during the activity and upon which the hazards of traveling are to be expected. I further agree and warrant that if at anytime I believe conditions to be unsafe, I will immediately discontinue further participation in the activity.

I fully understand that (a) bicycling activities involve risk and dangers of serious bodily injury, including permanent disability, paralysis, and death ("risks"); (b) these risks and dangers may be caused by my own actions, or inactions, the actions or inactions of

others participating in the activity, the condition in which the activity takes place, or the negligence of the releases named below: (c) there may be other risks and social and economic losses either not known to me or not readily foreseeable at this time; and I fully accept and assume all such risks and all responsibility for losses, costs, and damages I incur as a result of my participation in the activity.

Having read this waiver and knowing these facts, I and anyone entitled to act on my behalf release the organizers volunteers, all city, county, state governments, and all sponsors (the releasees) from all claims or liabilities of any kind arising out of my participation in the event. To release, waive, hold harmless, discharge, and covenant not to sue to releases from any and all liability, claims, actions, demands, expenses, attorney fees, breach of contract actions, breach of statutory duty or other duty of care, warranty, strict liability actions, and causes of action whatsoever, that I might have or may acquire in the future, arising out of or related to any loss, damage, or injury, including death, that may be sustained by me (or my child), or to any property belonging to me (or my child), while participating in the 2019 Legacy Ride including, but not limited to, any claim that the act or omission complained of was in whole or in part the negligence or carelessness of the releasees. The event will be held rain or shine unless deemed detrimental to the participants by the organizers.
